Honourable and esteemed servants of the People of Canada,

I have previously made several [confessions](#), to all authorities addressed herein, to the possession of roughly twenty grams of cocaine with the intention to traffic with a written constitutional defence that I believe is consistent with prior precedent. I have also taken a [video](#) of myself selling my first gram of cocaine in a hand to hand transaction and [posted it publicly](#) online and [provided authorities](#) with the link to the video.

I have received no notice by authorities of any intention to intervene in my sales. I have also not received any denial by authorities of any potential validity of my constitutional defence.

Given that [section 1](#) of the *Constitution Act, 1982* states that the law must be prescribed, I intend no disrespect nor defiance in acting upon the possibility that failure by authorities to deny any validity of my defence may constitute tacit acquiescence, until further notice, to the potential validity of my constitutional claims, and thus it may appear that I am not acting unlawfully in planning my intended conduct. If I am notified of an intention by authorities to address [constitutional reference questions](#) to courts to receive definitive affirmation as to the validity of my claims, then I certainly intend to cease and desist with my intentions until the questions have been decided by the honourable Court.

I am now planning to produce a business card that I intend to circulate among people I meet who express an interest in the defence I am using for the conduct I am engaging in. In a continued wish to respectfully keep authorities apprised of the details of my intentions, unless and until I am notified that authorities have decided my defence is consistent with precedent or take any other relevant action such as prosecution, I would like to have the card viewed by enforcement and prosecution authorities and relevant health authorities to know whether the distribution of this card may warrant intervention by authorities, or more importantly, if any suggestions might be made as to how any substantial public interests could be better served by altering this card.

The content of the business card, as per my present plans, is printed below.

Enforcement authorities have been informed of my sales and they have not indicated any intention to intervene.

I must, by law, adhere to regulations in the course of any such sales, which can be found at: issociety.org/wp-content/uploads/Commerce-Charter-drugs-and-substances.pdf

If you find me failing to adhere to the above regulations and you bring evidence to authorities, then I may rightly expect to be imprisoned for trafficking as my defence would be voided.

I repeat my note to authorities from previous correspondence on this matter that it is my understanding that decriminalization of drugs in Switzerland and Portugal has led to substantial reductions in drug associated deaths. The honourable Hedy Fry, Member of Parliament, in an interview with the Georgia Straight in February 2017, "listed a number of benefits [of decriminalization] she said have been studied at length and proven in peer-reviewed literature", having travelled to Switzerland herself to get a close up view of the effects of decriminalization. Please note that a file number, VA22-71910, has been started at the Vancouver Police Department regarding some recent interactions with myself regarding the matters described herein.

I restate my intention, if notified by authorities that prosecution against me is being planned, to surrender the 20 grams of cocaine in my possession to authorities so that it may be used as

evidence against me. I would then gratefully invoke my constitutional defence to test whether the court affirms its validity.

If, on the other hand, an appropriately designated authority such as the [Director of Public Prosecutions](#) affirms that my defence is sufficiently consistent with the Constitution that prosecution is unnecessary, then as [God is named in the Constitution](#), I would appropriately offer my humble gratitude to Canada's servants of the supreme power(s) of creation for the defence of constitutional rights that prevailing authorities have chosen, apparently at God's behest, to undertake as their charge.
