Dear CoV license inspector,

I am writing to report a violation of CoV *License By-law* no. 4450 (the "*By-law*" herein), section 3, found on page 24 at <a href="https://bylaws.vancouver.ca/4450c.PDF">https://bylaws.vancouver.ca/4450c.PDF</a>, and providing the evidence at my disposal, to assist in upholding business laws in the city.

It is my understanding that the retail dealer who I am implicating has been selling cocaine in the City of Vancouver for roughly a year now, having now sold roughly 30 grams. It is my understanding that the retail dealer claims to have a constitutional defence for his violations of the *Controlled Drugs and Substances Act* that the Public Prosecution Service of Canada may find sufficiently consistent with precedent to make prosecution inappropriate despite having sufficient evidence to otherwise easily have him convicted. It is my understanding that the retail dealer has applied for a business license to sell cocaine in the City of Vancouver and been denied. Therefore I would like to see this retail dealer fined as per the *By-law*, section 30, page 79-80, in an amount not less than \$250.00 and not more than \$10,000.00.

The legal name of the retail dealer is Samuel Michael Frank, going by the pseudonym of Psamn Frank.

I can provide two pieces of evidence of Mr Frank's operations in the city:

- 2. The *By-law* states that "[n]o person shall carry on within the City any business, trade, profession or other occupation without holding a subsisting City license therefor".


I have worked several jobs in the City of Vancouver. I have always worked for employers who have diligently fulfilled the requisites for operating a business reputably and within the bounds of
